The Pendal Australian Long/Short Fund (**Fund**) is designed for consumers who are seeking [Capital Growth or Income Distribution](#), are intending to use the Fund as a [Core, Minor or Satellite Allocation](#) within a portfolio, have a minimum [5 years or longer](#) investment timeframe, have a [High or Very High](#) risk and return profile, and are unlikely to need to access their capital within [One Week](#) of request.

## About the Fund

**Investment Objective:** The Fund aims to provide a return (before fees, costs and taxes) that exceeds the S&P/ASX 200 (TR) Index over the medium to long term by taking both long and short positions in Australian shares.

**Product Description:** The Fund is an actively managed portfolio of Australian shares investing in both long and short positions. The Fund is designed for investors who want the potential for long-term capital growth and income, diversification across a broad range of Australian companies and industries through both long and short positions and are prepared to accept higher variability of returns. The Fund invests primarily in Australia but may also invest in New Zealand. The Fund may also hold cash and may use derivatives.

**Portfolio Diversification:** The Fund is comprised of 95-135% Australian shares (Long), 0-35% Australian shares (Short) and 0-5% Cash. The Fund provides broad exposure across Australian shares. Its portfolio diversification has been assessed as Medium.

**Risk Level:** High.

High risk of losing money in any year. Likely to produce higher returns over the long term.

**Suggested Length of Investment:** This product is designed for consumers who seek to invest their capital for a minimum period of five years.

**Access to Capital:** Under normal circumstances, withdrawal requests may be made on any Business Day and requests received by the Fund's cut off time on any Business Day will generally be processed on the following Business Day. A Business Day being a day other than a Saturday, Sunday or public holiday, on which banks are open for general banking business in Sydney.
